- 1. ICSD Procedures for Standards Development The 03.17.15 version of this document is the latest version of this document approved by ANSI and was accredited by ANSI on 02/11/13. These are the procedures that the ICSD has followed in revising the 1–2013 Standard to the 1–2018 Standard, and these are the procedures that will be used to audit IACET in 2019. The ICSD has made every effort to comply with these procedures. These procedures are due for reaccreditation every five years; thus, they need to be revised and re–submitted to ANSI by March 2018.
- 2. The BSR-9 and the required evidence that the ICSD followed its procedures will be submitted to ANSI for review and approval on September 15.
- 3. ANSI/IACET 2018 Standard The Standard has been reviewed by the copy editor and the ICSD is currently reviewing the comments and edits. The ICSD will be meeting tomorrow to approve the Standard, and it will then be ready for approval by the Board and submission to ANSI.
- 4. New AP Application has been created, approved and submitted to the copy editor for review. The ATF will review the changes and editor comments to see that they meet the letter and intent of the Standard. The Application will then be revised and approved by the full ICSD. Projected date of September 21, 2017.
- 5. Renewal AP Application A draft has been finalized and is currently in review. It is planned for approval by the full ICSD by September 25, 2017.
- 6. Resource Guide is complete and will be docketed for approval at the September 20/21 ICSD meeting (date TBD).
- 7. Commissioner Training -Commission is taking the lead with ICSD support.
